

Background



Baitadi District; historical name "Bairath", a part of Sudurpaschim Province, is one of the 77 districts of Nepal. It is a Hilly district. Baitadi, with Dashrathchand as it's headquarter, covers an area of 1,519 km² (586 sq. m) and has a population of 250,898 as per the census (2011). Baitadi district entails 56 village development Committee (VDCs) and two municipalities. Baitadi falls into the farthest western regional district of Nepal touching Jhulaghat, India, to its border, Nepal's neighboring country.

Amongst them, Surnaya Rural Municipality is the one having an area of 124.52 km² where the whole training service is concentrated and going to be held. According to Cencus 2011 total population of the municipality is 18549 among which 45.7 % are male and 54.3% are female. In numbers the total population of male are 8471 and female are 10078. So density of population is 149 per sq km in surnaya rural municipality among its land covered by 124.52 sq. Km.

Background of the Project

Famous education theorist Paulo Frey did extended research on education, Based upon his fundamental research proposal .He devised basically a three paradigm of education namely

In context of Nepal, pedagogy is practiced on school level. While and ragogy has been practicing in community basis since 2072 B.S. up to the present. On the other hand, reflect approach has been practicing at rural part of India and developing nations as sustainable methodology to uplift the community education. In Bihar of India , reflect approach has been enforced successfully as a pilot project to meet the objective for community based women empowerment.

At present scenario, Because of lack of awareness on public health and depriving vital education on sex and pregnancy education, Nepalese women are undergoing through prolonged problems such as child marriage, polygamy, under nutrition, miscarriage, misconception regarding mensural cycle, social norms and values.

In present context of Nepal, because of unorganized living, lifestyle and existing cultural norms and values, there is existence of issues and problems in public domain. One the major cause is the child marriage. Nepalese present laws and constitution has provisioned for rightful marriage after 20 years only.
