
7. Matters not covered by this notice shall be in accordance with Public Procurement Act, 2063 and Public Procurement Regulations, 2064 and other prevailing regulations.

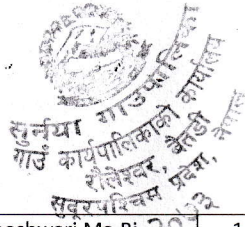




